NEW PHCCI-MPC Tacloban COOPAGTUTULUNGAN PROGRAM 2018

WHAT IS A COOPAGTUTULUNGAN PROGRAM:

PHCCI-MPC Tacloban COOPAGTUTULUNGAN PROGRAM IS A MORTUARY FINANCIAL ASSISTANCE PROGRAM OF PHCCI REGULAR MEMBERS EXTENDED TO THE FAMILY OF PHCCI-MPC Tacloban COOPAGTUTULUNGAN MEMBERS IN TIME OF DEATH.

THERE WILL BE ONLY ONE COOPAGTUTULUNGAN PROGRAM FOR THE ENTIRE PHCCI-MPC Tacloban TO INCLUDE THE BRANCHES AND SATELLITES OF PHCCI-MPC Tacloban.

A. PRIMARY PURPOSE:

1. TO PROVIDE FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF PHCCI-MPC Tacloban COOPAGTUTULUNGAN MEMBER IN TIME OF DEATH.
2. TO MANIFEST BROTHERHOOD/SISTERHOOD IN THE SPIRIT OF COOPERATIVISM AMONG MEMBERS.

B. GUIDELINES:

1. ALL MEMBERS OF THE EXISTING PHCCI-MPC Tacloban COOPAGTUTULUNGAN MEMBERS OF THIS 2018 PHCCI-MPC Tacloban COOPAGTUTULUNGAN PROGRAM.
2. ALL NEW COOPAGTUTULUNGAN APPLICANT-MEMBER SHALL PAY A ONE-TIME REGISTRATION FEE OF ONE HUNDRED PESOS (P100.00) TO THE PHCCI-MPC Tacloban COOPAGTUTULUNGAN PROGRAM AND ANNUAL CONTRIBUTION OF P600.00 TO BE FULLY PAID 1ST QUARTER OF THE YEAR.
3. AN APPLICANT MUST BE AT LEAST EIGHTEEN (18) YEARS OLD BUT NOT OVER SEVENTY (70) YEARS OLD AT THE TIME OF APPLICATION FOR MEMBERSHIP IN THE PHCCI-MPC Tacloban COOPAGTUTULUNGAN PROGRAM.
4. NEW REGULAR MEMBERS WITH AGES SEVENTY (70) YEARS ABOVE, WHO ARE NOT YET MEMBERS OF THE COOPAGTUTULUNGAN MAY JOIN PROVIDED THEY WILL

CONTRIBUTE P600.00 ANNUALLY AND WILL ONLY BE ENTITLED TO TEN THOUSAND PESOS (P10,000.00) BENEFIT.

5. ASSOCIATE MEMBERS WITH AGES 70 YEARS ABOVE MAY JOIN THE COOPAGTUTULONGAN PROVIDED THEY HAVE DEPOSITED P1,200.00 PREFERRED SHARES AND PAID P600.00 AND WILL ONLY BE ENTITLED TO TEN THOUSAND PESOS (P10,000.00) BENEFIT.

C. REQUIREMENTS TO BECOME A MEMBER OF PHCCI-MPC Tacloban COOPAGTUTULUNGAN PROGRAM:

1. MUST MAINTAIN A SHARE CAPITAL OF AT LEAST ONE THOUSAND TWO HUNDRED PESOS (1,200.00).
2. MUST MAINTAIN A SAVINGS DEPOSIT OF AT LEAST ONE THOUSAND PESOS (P1, 000.00).
3. MUST HAVE A COOPAGTUTULUNGAN SPECIAL SAVINGS DEPOSIT OF SIX HUNDRED PESOS (P600.00)

EXEMPTED FROM THE REQUIREMENTS:

- A. FOUNDING MEMBERS ARE EXEMPTED FROM THESE REQUIREMENTS.
- B. REGULAR EMPLOYEES REACHING COMPULSORY RETIREMENT WITH AT LEAST TWENTY (20) YEARS OF CONTINUOUS SERVICE.
- C. REGULAR MEMBERS WHO RELIGIOUSLY PAID THE COOPAGTUTULONGAN FOR 40 YEARS

D. FUND SOURCE:

1. THE CORRESPONDING BENEFIT DUE TO THE QUALIFIED BENEFICIARY SHALL BE TAKEN FROM THE SPECIAL COOPAGTUTULUNGAN PROGRAM.

E. BENEFIT/ENTITLEMENT

1. SEVENTY THOUSAND PESOS (PHP70,000.00) FINANCIAL ASSISTANCE: PROVIDED, MEMBER:
 - A. MEMBER SATISFIES PROVISION C1 TO C3.
 - B. MEMBER HAS BEEN A MEMBER OF COOPAGTUTULUNGAN PROGRAM FOR AT LEAST ONE (1) YEAR; AND
 - C. MEMBER HAS PATRONIZED ONE (1) PHCCI-MPC Tacloban PRODUCT WITHIN THE LAST TWENTY-FOUR (24) MONTHS LIKE LOAN AVAILMENT OR SAVINGS.
2. SEVENTY THOUSAND PESOS (PHP70,000.00) FINANCIAL ASSISTANCE TO THE FAMILY OF FOUNDING MEMBERS OF PHCCI-MPC Tacloban WHO ARE NO LONGER MEMBERS AT THE TIME OF DEATH.
3. TEN THOUSAND PESOS (PHP10,000.00) FINANCIAL ASSISTANCE FOR COOPAGTUTULUNGAN MEMBERS WHO DO NOT QUALIFY UNDER E1.

F. REQUIREMENTS FOR CLAIM

1. DEATH CERTIFICATE AND OTHER ALTERNATIVE PROOF OF DEATH AND IDENTITY OF THE MEMBER.

G. OTHERS

UPON DEATH, FIFTY PERCENT (50%) OF THE BENEFIT WILL BE DEDUCTED FROM THE MEMBERS WITH OUTSTANDING LOAN BALANCE.
